The Scheme became effective on 5th November, 2016. As on 31st December, 2016 total 160,725 (representing 0.05%) equity shares held by South West Electronics Private Limited (11,122 Shares), Tapti Appliances Private Limited (35,566 Shares), Elegance Appliances Private Limited (59,644 Shares), Neetu Appliances Private Limited (739 Shares) and Yakme Electronics Private Limited (53,654 Shares) have been transferred in the name of Roshi Appliances Private Limited. Balance 2,11,000 Shares held in the name of Neetu Appliances Private Limited have also now been transferred in the name of Roshi Appliances Private Limited. As such as on 31st March, 2017, Roshi Appliances Private Limited holds 371,725 Equity Shares (representing 0.11%).
