**NOTIFICATION FOR THE ATTENTION OF THE CREDITORS OF THE 13**  
**VIDEOCON GROUP COMPANIES**  
**(UNDERGOING CONSOLIDATED CORPORATE INSOLVENCY RESOLUTION**  
**PROCESS, UNDER INSOLVENCY & BANKRUPTCY CODE, 2016)**

As you are aware, the Hon'ble National Company Law Tribunal, Mumbai Bench ("NCLT") had *vide* its orders admitted the applications for the initiation of the corporate insolvency resolution process ("CIRP") of the 13 Corporate Debtors (*as listed in column 2 of Schedule 1 hereto*) in terms of the Insolvency and Bankruptcy Code, 2016 read with the rules and regulations framed there under, as amended from time to time ("Code"). The public announcements inviting claims from the public at large for each of the Corporate Debtors were made on the respective dates specified in column 4 of the Schedule 1 hereto. Subsequently, the NCLT ordered the consolidation of the CIRP of 13 Corporate Debtors and that the undersigned was appointed as the Resolution Professional for the consolidated CIRP of the Corporate Debtors *vide* an order of the NCLT dated September 25, 2019 (published on September 27, 2020).

Please note that the CIRP of the Corporate Debtors is now at an advanced stage wherein the resolution plans have been tabled before the committee of creditors for their approval. In light of the same, please note that all claimants are requested to submit their claims against any of the Corporate Debtors by November 17, 2020 ("**Due Date**"). Any claims received against any of the Corporate Debtors after the aforementioned Due Date shall not be considered by the undersigned.
