

## **NOTICE FOR APPOINTMENT OF RESOLUTION PROFESSIONAL**

This is to bring to your notice that the consolidated committee of creditors ("CoC") of 13 Videocon Group Companies (collectively referred to as the "Corporate Debtors") pursuant to its meeting held on September 16, 2019 resolved, with requisite majority required under the Code to replace the existing Resolution Professional, i.e. Mr. Mahender Khandelwal with Mr. Abhijit Guhathakurta as the resolution professional for the Corporate Debtors in accordance with Section 27(2) of the Insolvency and Bankruptcy Code, 2016 ("Code")

Pursuant thereto, the Hon'ble National Company Law Tribunal has appointed Mr. Abhijit Guhathakurta as the Resolution Professional of Consolidated CIR Process of the Corporate Debtors ("RP") vide its order dated September 25, 2019, which was published on September 27, 2019 ("Order of Replacement")

By virtue of the provisions of the Code on and from the date of publication of the Order of Replacement of the RP, i.e. September 27, 2019:

- a) the existing Resolution Professional has been substituted by the RP;
- b) the management of the affairs of the Corporate Debtor vests in the RP;
- c) the powers of the board of directors are to be exercised by the RP;
- d) the officers and managers of the Corporate Debtor are required to report to the RP and provide access to such documents and records of the Corporate Debtor as may be required by the RP; and
- e) the financial institutions maintaining accounts of the Corporate Debtor are required to act on the instructions of the RP in relation to such accounts and furnish all information relating to the Corporate Debtor available with them to the RP.

In view thereof, please take note of the above appointment of the RP and in case any correspondence is required to be made in respect of the Corporate Debtors during the corporate insolvency resolution process, including but not limited to submission of any claims the same should be addressed to the RP, in addition to any copies being issued to the office of the Corporate Debtors directly.
