S.Z. Deshmukh & Co, Chartered Accountant (Firm Registration No: 102380W) from the position of the Statutory Auditors of the Company w.e.f financial year commencing on April 1, 2019. Further, the CoC, vide requisite majority has on June 17, 2022 approved appointment of M/s KVA & Company, Chartered Accountant (Firm Reg. No: 017771C) as the Statutory Auditors of the Company for a period of five (5) years to hold the office as such and conduct audit of the Company for the financial years commencing from April 1, 2019 to till the financial year ending on March 31, 2024.
