In terms of Regulation 30 read with Schedule III, Part A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), this is to inform you that, based on the media reports, it has come to the knowledge of Videocon Industries Limited (the "Company"), a Company under corporate insolvency resolution process, that Mr. Venugopal Nandlal Dhoot, Chief Executive Officer and Promoter of the Company had been arrested by the Central Bureau of Investigation and produced before the Hon'ble Special CBI Court in connection with probe into certain loans sanctioned by ICICI Bank to Videocon Group. Further, basis the media report(s), the Hon'ble Special CBI Court remanded Mr. Venugopal N Dhoot in CBI's custody till December 28, 2022.

It is further informed that except the media reports, the Company is not in possession of the relevant order passed by the Special CBI Court or any documentary evidencing the same.
